WHEREAS, it is noted that only the name of M/s..... (**Generator's Old Name**) has changed to (**Generator's New Name**) and all other constraints of PPA, liabilities of seller, share holding pattern are same.

WHEREAS, the Competent Authority of MSEDCL has accorded approval to make amendment in the Power Purchase Agreement dated as regards the change in name and style of the seller from (**Generator's Old Name**) to M/s (**Generator's New Name**)

NOW, the Parties hereto agree to and confirm the terms and conditions set out below based on the representations, mutual promises and covenants as mentioned herein and the Agreement:

(1) All the Terms and Conditions of the Power Purchase Agreement dated between MSEDCL and (Generator's Old Name) shall remain unchanged & will be binding on (Generator's New Name).

(2) MSEDCL is indemnified against any dispute between M/s. (Generator's Old Name) and / or (Generator's New Name).
