Sir,

With reference to above subject, it is to inform that, vide letters under reference sr.no. 1 to 3, this office had accorded vendor approvals to your firm for supply of 11 KV & 22 kV RMU on the basis of certain documents such as- Type Test Reports, Drawings, GTP etc. submitted alongwith the proposals.

- On verification of the Type Test reports, from CPRI, Bengaluru laboratory (from whom the same have been pretended to be issued) vide their report under reference letter at sr. no 4, CPRI informed that the type test reports were not issued by them and found fake and fabricated.
- 2) Since, the alleged malpractice of playing fraud on MSEDCL by submitting such fake or forged documents by your concern, has attracted the ground for debarring your firm from the business dealing with MSEDCL as contemplated under Clause No. 10.1(a) of 'MSEDCL's Debarring Policy'.
- 3) Further, Show -Cause notice was issued by this office vide Letter No CE/Testing/Tade RMU/301836 dt.13.01.2023 stating "Why the action of debarring your firm from business dealings with MSEDCL shall not be taken against your Firm." and to the same you have replied vide your letter under ref. no. (7), was not found satisfactory because you have committed violation of the conditions of MSEDCL for vendor approval.

4) As per competent authority approval vide ref office note (8) it has decided "to cancel the vendor approvals awarded vide letters under ref sr. No. 1, 2 and 3 for supply of 11KV and 22 KV RMU's with immediate effect and to debar your firm from business dealing with MSEDCL for a period of Three Years from the date of issuance of this letter. The material supply/purchase process if initiated in respect of MSEDCL is hereby terminated with immediate effect. MSEDCL is not bound to bear any financial losses accounted on your side due to debarring.
